HEALTH AND SAFETY GUIDELINES

CAMP CONNECT 2022

To ensure the safety of all our students/adults, families and staff, we must follow the guidelines of the Center for Disease Control issued by the Health Department. Please do not send your child or adult to Madonna Learning Center if he/she exhibits any of the guidelines listed below. If, on arrival, a client appears ill and/or exhibits any of the guidelines listed below, Madonna staff will request that the student/adult return home and not enter the school building. Should a student/adult become sick and/or exhibit any of the guidelines listed below, while at Madonna Learning Center, parents or emergency individuals will be contacted. The student/adult must be picked up from Madonna Learning Center within 30 minutes (if residing within Shelby County) or 60 minutes (if residing outside Shelby County).

The guidelines are as follows:

1. Fever free without use of fever reducing medicines (Tylenol Advil...) for 24 hours. Normal temperatures are 98.6 oral, 99.6 rectal, and 97.6 axillary (under the arm).
2. No vomiting and/or diarrhea for 24 hours (bowel movements and food and fluid intake should be back to normal).
3. No colored drainage from any body part (this includes eyes, ears, nose and sores). If a child or adult has been on antibiotics for 48 hours and still has colored drainage (yellow green or brown), they may return to program.
4. No rashes of any sort unless seen by a doctor and the doctor has written a note stating that the rash is not contagious.
5. Vigilant hand washing (soap and water) before and after toileting/changing diapers (this includes the child's hands), and before all meals including snack

*****This is the best way to prevent the spread of infection*****

It is very important that all families and staff use their best judgment. If you or your child is not eating, drinking, sleeping normally, or still "run down", the body's resistance is still low and an infection with a different organism ("bug") is very likely.

Please remember that even if on an antibiotic, one can still catch a virus.

Release of Liability (“Release”)

for Camp Connect and Monarch Camp

I/we, _____, the parent(s), legal guardian(s), or conservator (“Legal Representative(s)”) of _____ (“Camper”), agree to allow Camper to participate in activities and programs at Madonna Learning Center (“Madonna”), and in consideration for the opportunity for Camper to participate in Madonna Camp programs and activities, and for other good valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, agree as follows:

1. Physical Events and Equipment. I acknowledge that Physical Education (PE), Yoga, Dance/Movement and similar activities (collectively “Physical Events”) have inherent benefits and risks, including the risk of physical injury. I understand and am aware that strength and flexibility training and other fitness activities, including the use of fitness or strength equipment, can be potentially hazardous activities. With acknowledgment of the foregoing, I hereby voluntarily give Camper permission to participate in all Physical Events and use fitness equipment, but only under the supervision of his or her counselor or supervisors or other Madonna staff.

2. Student Condition(s). I hereby declare that I will notify the supervising camper and staff of Madonna of any condition, impairment, disease, infirmity, or illness that would prevent Camper from participation in any of Madonna’s Camp activities and programs. I hereby acknowledge that I have been informed of the need for a physician’s approval for Camper’s participation in any exercise/fitness activities or use of exercise equipment and machinery. I also acknowledge that it has been recommended that Camper have a yearly (or more frequent) physical examination and consultation with his/her physician with regard to physical activity, exercise, and use of exercise and training equipment.

3. Pandemic. I understand and acknowledge that the coronavirus (“COVID-19”) has been declared a global pandemic, is extremely contagious and believed to spread mainly from person-to-person contact. I further understand there may be other similar types of viruses in the future. Madonna is and will continue to follow federal, state, and local guidance and has and will use best efforts to put in place preventative measures to reduce the spread of COVID-19 and similar viruses in the future; including, but not limited to, cleaning procedures recommended by the CDC. I acknowledge that Madonna cannot guarantee that Camper or I will not become infected with COVID-19 or any other viruses. I further acknowledge that attending Madonna could increase my risk and Camper’s risk of contracting COVID-19 or any other viruses.

4. Assumption of Risk.

(a) I, in my capacity as Legal Representative of Camper, have knowingly made the determination that the potential benefits to Camper participating in Physical Events and activities are greater than any risks assumed,

and I hereby knowingly and voluntarily assume and accept any and all risk of injury to Camper as a result of participation in Physical Events, use of fitness equipment and/or other related activities.

(b) I furthermore acknowledge the contagious nature of COVID-19 and other similar viruses and voluntarily assume the risk that Camper and I may be exposed to or infected with COVID-19 (or similar viruses) by attending Madonna and participating in Madonna's Camp programs and activities, and that such exposure or infection may result in personal injury, illness, permanent disability, and/or death. I understand and hereby acknowledge, independently of any advice or representation made by Madonna, that participation in activities or programs at Madonna during the COVID-19 pandemic or any future pandemic presents certain risks beyond Madonna's control, and which may exist regardless of whether Madonna controls or attempts to control such risks even if Madonna exercises the utmost care in trying to prevent anyone from getting injured or sick. I am permitting Camper to participate in activities and programs at Madonna with this understanding, and hereby knowingly and voluntarily assume all risks of injury, illness, death or damage related to COVID-19 or other viruses which may arise as a result of Student participating in activities or programs at Madonna. Camper's attendance and participation in programs and activities at Madonna is voluntary, and I understand and acknowledge that I may choose to not have Camper attend Madonna, or I may discontinue Camper's attendance at Madonna at any time in light of the risks I am assuming hereunder.

5. Release of Liability. As Legal Representative and on behalf of Camper, I hereby forever release, waive, covenant not to sue, discharge, and hold harmless Madonna, its trustees, officers, employees, staff and agents of any kind thereof (collectively the "Released Parties"), from, without limitation, any and all liability, loss, damage, claims, assertions and/or expenses of any kind or nature (including attorneys' fees, fines and/or penalties and related expenses) with respect to which I, Camper or my family, estate, heirs or assigns might have or could have against the Released Parties as a result of bodily injury or illness to myself or Camper, including death, caused by any acts or omissions of any kind or character whatsoever related to Camper's participation in any Physical Events, using any equipment, and/or contracting COVID-19 or any other viruses arising from or out of the Camper's participation in any summer camps, activities or programs at or provided by Madonna, transportation provided by Madonna, or the use of Madonna facilities, equipment, or materials. I furthermore also agree to forever release, waive, covenant not to sue, discharge, and hold harmless any third parties related to, or connected in any way with, any summer camps, activities or programs at or provided by Madonna, transportation provided by Madonna, or the use of Madonna facilities, equipment, or materials.

6. Indemnity. As Legal Representative and on behalf of Camper, I agree to indemnify, defend, and hold harmless the Released Parties to the fullest extent permitted by law, from and against any and all costs, expenses, damages, claims, lawsuits, judgments, losses, and/or liabilities (including attorneys' fees, fines, and/or penalties) arising either directly or indirectly from or related to any and all claims made by or against any of the Released Parties due to bodily injury, death, loss of use, monetary loss, or any other injury from or related to my or Camper's participation in summer camps, activities or programs at or provided by Madonna, transportation provided by Madonna, or the use of Madonna facilities, equipment, or materials, whether caused by the negligence of the Released Parties or otherwise specifically related to Physical Events or COVID-19 or other similar viruses.

7. Madonna's Rules and Regulations. I acknowledge and agree that Madonna and its board members, officers, faculty, staff or agents (as Madonna deems necessary), shall have the authority to establish rules and regulations regarding Camper attending and/or participating in Madonna activities. Specifically, Madonna can disallow Camper's attendance or participation in activities at Madonna if it is determined that Camper has symptoms of COVID-19 or any other virus. To that end, I agree to permit Madonna to take Camper's temperature any time that Camper is at a Madonna facility. I further agree to monitor Camper's temperature and condition before allowing him or her to participate in any activities at Madonna or sponsored by Madonna and agree that I will not allow him or her to participate in any Madonna activity if Camper is showing any sign of illness. I agree that Camper and I will follow and be bound by the rules and regulations contained in this paragraph and all other Madonna rules and regulations.

8. Insurance. I understand and acknowledge that Madonna has no insurance that will pay for, or reimburse me for, any expenses of any kind which I may incur for treatment of illness or injuries sustained while participating in any programs at Madonna. I hereby assume all responsibility for any such costs and expenses.

9. Representations. (i) I am an adult, and I am the Legal Representative of Camper; (ii) I have the legal capacity to execute and to be legally bound by this agreement with Madonna and waive certain of my legal rights as provided herein; and (iii) I have read each paragraph and fully understand the terms and conditions of this Release and have been provided with the opportunity to discuss it with anyone of my choosing, including a lawyer.

10. Governing Law and Severability. I agree that this Release shall be governed by and construed in accordance with the laws of the State of Tennessee. The terms and provisions of this Release shall be severable, such that if a court determines any term of this agreement to be illegal, unenforceable or in conflict with applicable law governing this Release, the validity of the remaining portions shall not be affected thereby. In the event of any dispute, Madonna shall be entitled to recover all of its attorneys' fees and costs.
